

## Definitions

<u>General Considerations</u> – Summarizes county expenditure data.

Technical Understanding of SPARK Process – Assesses compliance of applicant expenditure information with SPARK guidance.

<u>Identified Compliance Considerations</u> – Highlights requested items that may present potential complications for CRF support eligibility.

<u>Spending Plan Request for Additional Information</u> – Specifies what information is still needed from the recipients.

<u>Modifications Required</u> – Requests any changes still needed to a Reimbursement or Direct Aid plan for proper review.

<u>Conclusion</u> – Gauges whether the county's plan has sufficient information to move forward in the eligibility review process and highlights any remaining concerns.

## **General Considerations**

Lyon County has prioritized its reimbursement requests for subrecipients, which comprises 86.44% of the report's total expenditures. Total County reimbursements equal 15.36% of all eligible expenditures, while both higher level and regular educational institution requests total 58.52% of the \$1,357,609.39 submitted for reimbursement review.

Lyon County's substantially larger direct aid request prioritizes transfer expenditures, which amounts to 76.36% of the \$6,318,739.61 submitted for direct aid review. Transfers to subrecipients increased significantly from the reimbursement request. Both higher level and regular educational institutions account for 76.70% of transfer requests while a government entity, homeless shelter, church, and four cities account for the remainder of requests.

The County should ensure that all expenses, transfers, and programs respond clearly to purpose and intent of CRF funding, meets all eligibility criteria, and will be documented to the county file to support the expense incurred before December 30, 2020.

## **Technical Understanding of SPARK Process**

Lyon County and its subrecipients demonstrate a generally proficient understanding of the intent of the SPARK committee and reporting expectations as exemplified by their detailed reporting of expenditures for reimbursements and direct aid.

## Identified Considerations

1. Payroll Expenses

The matter of reimbursement for previously budgeted but substantially dedicated public safety and public health staff to COVID-19 related responsibilities remains an item of subjective interpretation.



The Office of Recovery understands that many Counties and Cities are intending to utilize funding provided through CRF to account for this staff time. At this time, consistent with recently released guidance, the Office of Recovery has determined that the County may proceed with reimbursing the following payroll expenses:

- COVID-19 related FFCRA and FMLA leave costs
- Payroll for budgeted personnel and services diverted to a substantially different use than previously budgeted position (example: utility clerk re-assigned to support contact tracing)
- Previously unbudgeted staff hired to assist with COVID-19 related response or mitigation.
- Payroll for budgeted public safety and public health personnel that are considered substantially dedicated to preparing for, mitigating against or responding to COVID-19, and whose actions can be clearly documented. Public safety employees would include police officers (including state police officers), sheriffs and deputy sheriffs, firefighters, emergency medical responders, correctional and detention officers, and those who directly support such employees such as dispatchers and supervisory personnel. Public health employees would include employees involved in providing medical and other health services to patients and supervisory personnel, including medical staff assigned to schools, prisons, and other such institutions, and other support services essential for patient care (e.g., laboratory technicians) as well as employees of public health departments directly engaged in matters related to public health and related supervisory personnel.
- Overtime cost burden associated with public safety, public health, health care, human services, or other employees experienced by the County, Cities or Schools as a result of increased workload associated with mitigating or responding to COVID-19 -or- backfill coverage as a result of staffing shortages tied to COVID-19 (including as a result of staff out due to a qualifying FFRCA or FMLA leave).

The U.S. Treasury's Office of Inspector General recently released additional guidance on how payroll expenses should be documented (OIG-CA-20-028; #62, 69-71). The County should ensure that all payroll is documented compliant to the OIG Guidance.

2. Small Business Economic Relief Grant Program

#### \$1,222,422.78 Direct Aid

As this is identified as a grant program, additional information is requested, including a description of how applicants will apply and be selected. Additionally, the County should ensure they have the appropriate level of administrative capacity to effectively monitor these subrecipients.

## Spending Plan Request for Additional Information

No additional information is requested at this time.

## **Modifications Required**

1. For the Direct Aid request for USD 253, the 'Date Expected' is listed as 12/31/2020 several times. Those dates should be changed to 12/30/2020 to reflect the program eligibility date.



# Conclusion

- 1. Based on the documents provided by Lyon County, it appears they have a good understanding of the eligibility requirements relative to CARES Act funding and have appropriately followed this process.
- 2. Lyon County has an appropriate Project Spend Down Rate representing a low risk of funds not being expended on or before December 30, 2020.
- 3. Lyon County has proposed many potential subrecipient arrangements. The County should ensure they have the appropriate level of administrative capacity to effectively monitor these subrecipients.
- 4. Lyon County should consider developing a templated sub-recipient monitoring plan to ensure consistent monitoring of subrecipients (cities, schools, non-profits) for compliance use of funds.
- 5. For the Lyon Grant Program, if not already in place, Lyon County should consider development of an application process and establish a review committee to ensure equal access to funds from potential qualified applications. The County should also appropriately advertise the program within the community.

Subject to review of the additional documentation requested and considerations regarding payroll expenses, Lyon County may proceed with implementation of its CARES Act funding allocation as outlined in its provided reimbursement and direct aid plan.
