This week's edition of the Office of Recovery Newsletter highlights funding for frontline nurses and care workers, financial assistance for agricultural producers, and support for small businesses impacted by COVID-19. Our Community Impact section goes in depth about \$50 million available for hospitals to either provide premium pay or improve retention of nursing resources and support personnel, approved by the SPARK Executive Committee last week. Our Program Spotlight section highlights the Pandemic Response and Safety Grant, available for agricultural producers and distributors to recover costs incurred by the COVID-19 pandemic. This section also details new support for small businesses, administered by the Small Business Administration (SBA). Last week, the SPARK Executive Committee also approved a structure for SPARK, with four advisory panels representing the four topic areas: economic revitalization, health and education, connectivity, and efficiency and modernization. The advisory panels will be composed of 8-10 experts.

Governor Laura Kelly Announces Funding for Frontline Nurses and Care Workers

Last week, Governor Laura Kelly announced \$50 million available for hospitals to either provide premium pay or improve retention of nursing resources and support personnel, approved by the SPARK Executive Committee. This emergency funding will provide immediate support for Kansas hospitals to manage the current COVID-19 surge.

Qualified facilities may use the funding for either premium pay as defined in the American Rescue Plan Act (ARPA) or for funding a program designed by the facility to improve the retention of nursing resources and support personnel.

"Many of our nurses are risking their lives every day to save Kansans from COVID-19 – and the immense strain on our hospitals is causing them to be exhausted and disheartened," **Governor Laura Kelly said.** "They're taking on extra shifts and caring for more patients than they can handle – and it's our responsibility to give them the support they need.

"Frontline nurses need this funding to continue battling the COVID-19 surge here at home. I sincerely thank all Kansas frontline nurses and health care workers for all they do to protect our communities from the threat of COVID-19. I encourage all Kansans to do their part and get vaccinated immediately – for our health care workers, for our businesses, and for our families."

The funding can provide frontline nurses and care workers with premium pay by increasing their hourly wages up to \$13 per hour. Hospitals can apply for these State Fiscal Recovery Funds and receive funding based on their number of beds, and will have flexibility over how to distribute premium pay.

Additionally, hospitals will be allowed to propose a plan other than premium pay to retain staff if it meets compliance with ARPA guidance and is approved by the Office of Recovery. Funding in retention programs must be spent on pay and associated benefits of qualified employees. Funding in both premium pay and retention programs must be spent in a manner that is **additive** to existing pay and benefit programs in place as of August 31, 2021.

Governor Kelly believes it is imperative to act now and protect the health and safety of our frontline nurses. This funding will ensure that Kansas hospitals are

adequately equipped with experienced staff, rural hospitals can keep their doors open, and nurses can appropriately be compensated for their tireless and courageous work throughout this pandemic.

More information will be provided to eligible Kansas hospitals in the coming days about how to access and properly allocate this funding to their nurses and frontline care workers.



New Support for Small Businesses Impacted by COVID-19

The Small Business Administration (SBA) is strengthening the COVID Economic Injury Disaster Loan (EIDL) program, which provides long-term, low-cost loans. This plan is aimed at helping more than 150,000 small businesses.

The Small Business Administration (SBA) will:

- Increase the maximum amount of funding a small business can borrow through this program from \$500,000 to \$2 million, which can be used to hire and retain employees, purchase inventory and equipment, and pay off higherinterest debt
 - SBA will ensure that no small business has to start repaying these loans until two years after they receive the funding
- Make it easier for small businesses with multiple locations in hard-hit sectors like restaurants, hotels and gyms to access these loans
- Offer a 30-day exclusive window of access where only small businesses seeking loans of \$500,000 or less will receive awards after the new and improved loan product launches
 - This is meant to ensure that Main Street businesses have additional time to access remaining funds

Financial Assistance for Agricultural Producers and Distributors

The United States Department of Agriculture (USDA) announced that it will soon publish a Request for Applications (RFA) for the Pandemic Response and Safety (PRS) Grant Program. The Pandemic Response and Safety (PRS) Grant Program provides funding to help small specialty crop producers, food processors, manufacturers, distributors and farmers markets recover costs incurred by responding to the COVID-19 pandemic, including for measures to protect workers. Funding for this program comes from the Consolidated Appropriations Act of 2021 (Pub. L. No. 116—260).

Eligibility

The PRS Grant Program provides grants to food processors, distributors, and producers that meet SBA small business size standards and farmers markets. The three industries that can apply for the program are:

- Crop production
- · Food manufacturing
- · Merchant wholesalers, nondurable goods

Businesses in these industries are limited to size standards – click here for a <u>full</u> <u>list</u> of business types and size standards to determine eligibility.

Application Overview

Application Period Opens: September 23, 2021

Application Period Closes: 11:59 PM Eastern Time on November 8, 2021

To apply, a business must first check eligibility <u>here</u> and have a DUNS number. Once the application opens on September 23, businesses can apply <u>here</u>.

All applications submitted before the deadline will be considered for funding. Applications will not be reviewed on a first-come, first-served basis.

Allowable uses

Grants will cover activities associated with:

- Workplace Safety: Implementing workplace safety measures to protect against COVID-19
- Market Pivots: Implementing market pivots to protect against COVID–19
- Retrofitting Facilities: Retrofitting facilities for worker and consumer safety to protect against COVID–19
- Transportation: Providing additional transportation options to maintain social distancing and worker and consumer safety to protect against COVID-19
- Worker Housing: Providing worker housing that protects against COVID-19
- Medical: Providing health services to protect workers against COVID-19

The minimum funding request amount if \$1,500. The maximum funding request amount is \$20,000. No cost sharing or matching funds are required.
