Funding Available to Ensure Kansans have Access to Drinking Water, Wastewater Services

Kansas households adversely impacted by the COVID-19 pandemic may benefit from a new program to help restore or prevent disconnection of drinking water and wastewater services.

The Emergency Water Assistance Program (EWAP) is a federally funded program that is being administered for Kansas residents by the Kansas Department for Children and Families (DCF).

"The program's sole focus is to restore or prevent disconnection of water to Kansas households," DCF Secretary Laura Howard said. "Kansas was awarded \$9 million to support hardworking Kansas households who have gotten behind on their water bills because of the pandemic."

Once the funding is exhausted, the program will end. Kansans may apply for this one-time benefit beginning December 1, 2021.

Learn if your household qualifies for the EWAP program:

The Emergency Water Assistance Program application for qualifying Kansas households will be available December 1, 2021. Once the funding runs out, the program will close. Submit the application as soon as possible on or after December 1.


An EWAP qualifying Kansas household is:

- Currently disconnected from drinking water and/or wastewater services or have received a disconnection notice.
- At least one adult household member must be responsible for drinking water and/or wastewater costs incurred at the primary residence payable to either the landlord or to the water utility vendor.
- At least one household member must be a US citizen or meet the lawful residency requirements.
- Combined gross income equal to or less than 150% of Federal Poverty Level (FPL).

"Public water utility partnership is vital to the success of the water assistance program," said Howard. "DCF is required to pay the public water utility provider, not the household. The sooner the utility company is in the system, the faster payment will be made on behalf of the household by DCF."

Water partners are asked to submit a signed water vendor agreement and tax documents that can be <u>found here</u>.

Governor Laura Kelly Announces the First Round of Grants to Community Organizations to Support COVID-19 Vaccination Efforts

To reaffirm her administration's support for local organizations engaged in efforts to increase COVID-19 vaccinations, Governor Laura Kelly has announced the first

round of Pandemic Assistance and Vaccine Equity Grants (PAVE) funding.

"The first round of PAVE grant funds will help our local organizations support their communities to beat this virus once and for all," **said Governor Laura Kelly.** "Local organizations know their constituents the best, and my administration is committed to supporting their efforts to increase vaccinations, keep our businesses open, and ensure every Kansan stays safe and healthy."

This program is specifically dedicated to reaching high-risk communities disproportionately affected by the COVID-19 pandemic, including underserved populations such as racial and ethnic minorities and rural communities. The 10 organizations receiving these funds will reach communities across the state to help increase the rate of COVID-19 vaccinations.

These organizations will use funds to provide COVID-19 vaccine education and resources to Hispanic and Black populations, limited English speaking persons, older adults, long-term care facilities, foster parents, single parents, persons with disabilities, schools, and rural communities. The grant will also fund transportation to vaccination sites and social media messaging and radio ads regarding the importance of vaccination.
