SPARK Updates

Department of Commerce BASE Program Application Closes February 28

The <u>Building a Stronger Economy (BASE) Program grant application</u> opened on Monday, February 1, 2022. The BASE program offers matching funds to address economic development opportunities with the goal of expanding the state's base of businesses and residents as we continue to recover from the effects of the COVID-19 pandemic.

The BASE grant application process will close on Monday, February 28, at 11:59 p.m. Grant awardees will be announced no earlier than March 25, 2022.

In December 2021, the SPARK Executive Committee approved \$100M in available federal COVID-19 relief funding for eligible economic development and infrastructure proposals. Projects that qualify under the requirements of the American Rescue Plan Act (ARPA) may receive matching funds to facilitate project completion.

County and local governments, Economic Development Organizations, local Chambers of Commerce, and other stakeholders are eligible to apply. Awardees will be provided with 50% of award allocation in calendar year 2022. The remaining 50% of funding will be provided no earlier than January 2023.

Stay Informed on the SPARK Process

The Strengthening People and Revitalizing Kansas (SPARK) Executive Committee oversees the distribution process of the American Rescue Plan Act (ARPA) Funding, assisted by four advisory panels with additional members. The Advisory Panels are focused on four main topic areas: Health and Education, Economic Revitalization, Connectivity, and Efficiency and Modernization.

On January 27, 2022, the SPARK Executive Committee launched an Investment Idea Submission Form for the public to submit their investment ideas for the use of State Fiscal Recovery Funds (SFRF) allocated to Kansas through the American Rescue Plan Act (ARPA). The Submission form closed on February 16, 2022. Over 750 total submissions from various stakeholders across the state were received.

The four Advisory Panels will meet over the coming weeks to develop investment recommendations for the SPARK Executive Committee to consider. Panels will look at investment idea submissions to help shape programmatic level recommendations. The Executive Committee will then consider these panel recommendations before sending them to the State Finance Council, which has final authority on investment decisions.

Additional updates will be provided throughout the SPARK process. All Advisory Panel meetings have and will continue to be streamed on the <u>Kansas Office of Recovery YouTube Page</u>. Meeting materials and recordings

Treasury Information



Navigating the US Treasury ARPA Reporting Portal

As a reminder, all Non-Entitlement Units of government (NEUs) that accepted funding through the American Rescue Plan Act (ARPA) are required to submit the first Project and Expenditure Report to the US Treasury by the deadline of April 30, 2022.

The Office of Recovery has received several inquiries on how to navigate the Treasury Reporting Portal. We have listed below a few useful resources to trouble shoot any problems you may have with the portal.

The <u>US Treasury Login.gov Reference Guide</u> provides step-by-step instructions on accessing and navigating the login and reporting process. Also available is the <u>Project and Expenditure Report User Guide</u> that details how to create and submit a report.
